Welcome to Canyon of the Eagles Nature Park and Resort. Thank you for taking the time out of your busy schedule to visit us. We know you have many choices for where you spend your “away” time, and we appreciate your decision to be with us.

Canyon of the Eagles is an ideal get-away, offering our guest the comforts of a full-service resort and the beauty, nature and tranquility of a 940-acre nature preserve. Nestled in the Texas Hill Country’s Upper Highland Lakes Region, Canyon of the Eagles takes its name from the American Bald Eagles that nest within the surrounding area from October through March each year. The Park is dedicated to showcasing the flora and fauna of beautiful Lake Buchanan and to providing a home for the endangered Black-capped Vireo and Golden-cheeked Warbler.

Located within this spectacular Lower Colorado River Authority Park (LCRA) is a full-service resort that features 62 guest rooms, outdoor swimming pool (resort/RV guests only), award-winning restaurant, lounge with beer/wine/liquor, lobby retail with gifts/snacks, 24-hour TV/recreation room, and meeting facilities that can accommodate up to 500 persons. Other park features include 33 campsites, 24 full-hookup RV sites with a main restroom and shower facility, a group campsite, an outdoor amphitheater, the popular *Eagle Eye Observatory* for stargazing, and 14 miles of designated nature trails for any age and ability.

Featured interpretative and entertainment programs consist of guided nature walks and hikes, reptile program, stargazing at Eagle Eye Observatory, guided scenic boat cruise, kayak rentals, movies “Under the Stars” and many more. Off-site activities may include extreme sports complex, Spider Mountain, Vanishing Texas River Cruise, Longhorn Caverns, over 30 vineyards and other nearby adventures. Canyon of the Eagles offers something special for every visitor. Please see our guest services for more information on the Park or surrounding areas.

The following items describe many of our features, but please do not hesitate to contact us if there is anything we can do to improve your stay. Our team is standing by ready to serve you.

GUIDELINES FOR AN ENJOYABLE STAY

ALCOHOLIC BEVERAGES: Visitors who are intoxicated or causing a disturbance may be removed from the park. **Only alcoholic beverages purchased from the Resort’s restaurant and bar are permitted in the public areas at the Resort.**

CAMPFIRES: Campfires are only permitted in established fire rings or in contained camp stoves. No gathering of standing or dead wood is permitted. No unsupervised campfires are allowed. During time of extreme fire hazard conditions, LCRA and/or Burnet County may declare a burn ban on all ground fires on all or part of the Park, as necessary for purposes of public health, safety and welfare. No person is allowed to light, build or maintain a ground fire within the Park while such a ban is in effect. No person is allowed to burn or dump trash, garbage, brush or other refuse within the Park.

CHECK-IN AND CHECK-OUT TIME: Check-in time is 2:00 p.m. and check-out time is noon. No RV or campsite will be allowed to check-in or setup during quiet hours, 10 p.m. until 6 a.m. daily. Any late checkouts will incur a \$20 per hour late fee.

CLEANUP OF SITE: It is your responsibility to make sure your site is free of trash and unwanted debris upon your departure. If your site is left with trash and unwanted debris that you have collected, you will be charged a minimum of \$50 for cleanup fee on your preferred method of payment to Canyon of the Eagles. Please dispose of all trash in the dumpsters or trash barrels located throughout the park.

DESIGNATED PUBLIC AREA: Picnicking and camping are allowed only in those areas so designated.

EMERGENCY & FIRE DEPARTMENT: Dial 911 on your cellular and then contact the guest services at the Resort. For veterinary services, please dial 512/756-7387 (Bluebonnet Veterinary Clinic). For non-emergency items please contact the guest services at 512/334-2070.

FIREARMS, HUNTING AND TRAPPING: No open carry is allowed at the resort or in the park. Guests violating this policy may be asked to leave. You understand and agree to hold the park harmless for any actions arising from a violation of the park's firearm policy. The transportation, possession or use of firearms, or any other type of weapon, and any and all types of hunting are illegal under state law and are strictly prohibited. No person shall place poisons or mechanical devices such as traps and snares within the Park.

GIFT SHOP: Ice, firewood, sundries, gifts, apparel, camping supplies, snacks, food, beverages, and other items are available at the resort's guest services. Hours of operation are posted throughout the park.

ICE MACHINE: Bags of ice can be purchased at the resort's guest services.

LOCAL ATTRACTIONS: We are near many central Texas attractions, such as caving and sightseeing tours. Please visit our guest services to get more information on *Things to do at or near Canyon of the Eagles*.

LOST AND FOUND: For information regarding lost and found items, please contact guest services.

MAIL AND SHIPPING SERVICES: Outgoing and incoming mail may be left or picked up at the resort's guest services. For additional services, a United States Post Office can be found in Burnet. Please contact the guest services for assistance with shipping and receiving.

MANAGER ON DUTY: Management is always available to help solve any situation that may arise. In the event a manager is needed, please contact the guest services 512/334-2070 and ask to speak to the Manager on Duty.

MAXIMUM OCCUPANCY: There is a limit of five (5) persons per RV site and eight (8) persons per campsite at any one time.

METAL DETECTORS: No person shall operate a metal detector within the Park or collect artifacts.

PETS: Pets are welcome at Canyon of the Eagles! There is a limit of two (2) pets per site (additional fee may apply). Pets must always be on a leash no longer than 6 feet including in your site area, the public areas and trails. Pets are not to be left unattended. Pets are not allowed, except as service dog, in food and beverage areas. In no case shall a pet be allowed to constitute a nuisance. Failure to control excessive barking or disturbing other guest may result in your removal from the Park. Guests are responsible for removing and disposing of waste associated with their pets. Failure to do so will result in a \$25 fee per occurrence.

QUIET HOURS: Quiet time in the Park is 10 p.m. to 6 a.m. No person shall cause or contribute to excessive noise during these hours. Noise that unreasonably disturbs other visitors is considered excessive. Generators and amplified music must be turned off between 10 p.m. and 6 a.m. Failure to cooperate with this policy may result in a fine from LCRA or Burnet Sheriff Department.

RESTAURANT & LOUNGE: The Resort's beautiful hilltop and award-winning restaurant with fireplace, patio and exterior desk overlooks the Texas Hill Country and features delicious and fresh signature dishes, appetizers, house-made desserts, house-made desserts, select wines, cocktails and assorted beers. The restaurant is casual and open daily for breakfast, lunch and dinner. **Dinner reservations are required.** Breakfast and lunch are on a first come first serve basis for all guests. Eagles Nest Lounge features a bar menu and televised events (hours may fluctuate seasonally). Both are perfect places to view spectacular

sunsets, distant thunderstorms and surrounding views of the Hill Country. **Please note that only alcoholic beverages purchased from the Resort's restaurant and bar are permitted within the Resort's common areas, patio, bar, swimming pool, recreation room and restaurant.**

SHOWERS AND RESTROOMS: Showers and restrooms are located on the main road at the entrance of the RV Park. All registered RVs, campers and park visitors may use this facility. Until further notice, all bath facilities are available 8 a.m. until 8 p.m. on daily.

SMOKING: All park buildings are nonsmoking, and you may find ash cans around the Park. Please do not throw cigarette butts on the ground. It is litter and creates an extreme fire hazard and may be picked up by the wildlife. Please respect your neighbors and the environment.

SPEED LIMIT: There is a speed limit of 10 miles per hour within the Resort, RV and camping areas.

SWIMMING POOL: **UNTIL FURTHER NOTICE, THE RESORT'S OUTDOOR SWIMMING POOL IS NOT OPEN OR AVAILABLE TO RV GUESTS DUE TO SOCIAL DISTANCING MANDATES.**

TEMPORARY OR PERMANENT STRUCTURES: Visitors are not allowed to place, construct, erect or occupy any temporary or permanent structure for human habitation or other purposes within the Park. No person shall install or construct electric, water, wastewater or other utility line or service upon, over or under the Park.

TENT CAMPING IN RV PARK: Tent camping is not allowed in the RV sites unless it is only one small tent, defined by 4 small children or 2 adults, and with a recreational vehicle, defined as a camper or motor home.

TRAILS: Over 14 miles of scenic and designated trails are offered for all age levels and abilities (some trails may be closed 3/1-8/31 for nesting season of our endangered birds). Most trails are designated for recreational biking. Stop by the Guest services for a map and directions. This is one of the best ways to enjoy the natural beauty at Canyon of the Eagles. Horses or non-company motorized vehicles are NOT allowed on the trails.

VEHICLES: Maximum of two vehicles are allowed per site with no exceptions. All vehicles must use the designated streets as provided. Please park within your own site. No vehicle repair or washing of vehicles is permitted on your site. Commercial vehicles, boats and extra vehicles are to be parked at the front gate parking lot. The extra vehicle charge is \$10 per vehicle per day. All vehicles must have current registration and license. Off-road vehicles are not allowed and subject to fines with LCRA.

VENDING MACHINES: 24-hour vending machines for soda and water are located outside the Resort's recreational room. The resort's lobby gift store has ice, firewood (seasonal), water, sodas, juice, candy and snacks for purchase (hours may vary seasonally).

VISITORS: ALL VISITORS MUST REGISTER AT THE RESORT'S GUEST SERVICES, ENTRANCE GATE OR AS DESIGNATED. Day use guests are not permitted to go into tent sites or RV sites to picnic.

WARNING: Please be careful and exercise caution at all times. You are staying in one of the most desirable areas in the Hill Country. While in the Park, please respect wild animals and the ecosystem at COTE. **Do not attempt to pet or feed the wild animals, especially the cute squirrels.**

We have many amenities and services available for your comfort and enjoyment. Our goal is to create a friendly, personal, and warm atmosphere where wonderful memories become a tradition. Please take the time to enjoy everything we have to offer, even the "little things!" Relax...and enjoy nature at its best. It is always an HONOR to serve you!
